**NOTICE OF INTENT OF INDIANOLA CITY COUNCIL TO HOLD A SPECIAL
ELECTION IN ACCORDANCE WITH IOWA CODE SECTION 372.2(2)**

TO: ALL CITIZENS AND PARTIES IN INTEREST WHO MAY BE ENTITLED TO NOTICE OF THE INDIANOLA CITY COUNCIL'S INTENT TO HOLD A SPECIAL ELECTION TO DETERMINE WHETHER THE CITY SHALL CHANGE TO A DIFFERENT FORM OF GOVERNMENT IN ACCORDANCE WITH IOWA CODE SECTION 372.2(2)

YOU ARE HEREBY NOTIFIED that on the 7th day of May, 2013, the City Council of the City of Indianola, Iowa intends to hold a special election for all eligible electors to determine whether the city shall change from a mayor-council form of government to a council-manager-at-large.

YOU ARE FURTHER AND SPECIFICALLY NOTIFIED that the electors of the City have the right to file a petition for appointment of a home rule charter commission pursuant to Iowa Code section 372.2(2)(a). The petition must be filed with the City Clerk not more than ten (10) days after the publication date of this Notice. The petition must be signed by a number equal to at least twenty-five percent (25%) of the eligible electors of the City who voted at the last regular city election. The filing of such a petition shall delay the election until after the home rule charter commission has filed a proposed charter. The commission shall have six (6) months from the date of its appointment to prepare and file with the council a proposed charter pursuant to Iowa Code section 372.9. Upon the filing of the proposed charter, the council and mayor shall direct that notice containing the full text of the proposed home rule charter, a description of the council-manager-at-large form of government, and the date of the election.
